TÜV SÜD America, Inc. (TÜV SÜD) conducted the verification of CHC's FY2025 Level 5 ACA Verification according to the requirements found in ISO 14064-3:2019, 14065:2020, & 17029:2019. The objective of this verification was to ensure that the GHG statement is materially correct and conforms to all relevant criteria. The GHG statement is the responsibility of CHC. A summary of the GHG statement is as follows:

- GHG-related activity: Christchurch International Airport (CHC)
- GHG statement: FY2025
- Criteria:
 - Airport Carbon Accreditation Application Manual Issue 14 (December 2023)
 - Airport Carbon Accreditation Carbon Offset Requirements, Issue 2 (June 2025)
 - Airport Carbon Accreditation Guidance on Reducing Emissions Before Offsetting Issue 1 (November 2020)
 - Airport Carbon Accreditation Verifier Manual Issue 1 (November 2020)
 - GHG Protocol, developed by World Resources Institute (WRI) and World Business Council on Sustainable Development (WBCSB)
 - New Zealand Standard on Assurance Engagements 1: Assurance Engagements over Greenhouse Gas Emissions Disclosures (August 2023)
 - ISO 14064-1 "Greenhouse Gases – Part 1: Specification with guidance at the organization level for quantification and reporting of greenhouse gas emissions and removals"
 - ISO 14064-3:2019 "Greenhouse gases – Part 3: Specification with guidance for the validation and verification of greenhouse gas assertions"

The data and information supporting the GHG statement were historical in nature.

For Scope 1 and Scope 2 sources, TÜV SÜD has ensured CHC's effective use of controls related to the GHG statement. TÜV SÜD concludes that there is sufficient and appropriate evidence to

support CHC's GHG statement and is issuing an Unmodified Opinion. For Scope 3 sources, based on the examination of the evidence, nothing comes to TÜV SÜD's attention which gives cause to believe that the GHG statement is not a fair representation of GHG data and information.

TÜV SÜD confirms that the GHG statement has been prepared:

- Without material discrepancy;
- in accordance with all applicable criteria; and
- verified to a reasonable level of assurance for Scope 1 and 2 emissions.
